ADDENDUM NO. 1 RESPONSES TO RFI's

PROJECT: REQUESTS FOR PROPOSALS FOR THE CITYWIDE TRAFFIC SIGNALS SYNCHRONIZATION PROJECT, CITY PROJECT NO. 23-01, FEDERAL PROJECT NO. CML-5254 (034).

Addendum No. 1 is being issued to the Notice to Proposers, for the **Requests for Proposals for the citywide traffic signals synchronization project**. Proposals submittals are due to be submitted by Thursday, November 30, 2023, at 2:00 P.M. in the City of Atwater, Community Development Department, located at 750 Bellevue Rd, Atwater, CA 95301.



2. Please provide an Inventory of existing wireless systems (with regard to the previous synchronization project) used in the city?
 - **Answer:**
 - **1) GPS Time Source Modules- McCain 2070 Plug-In (2070-7G)**
 - **2) Wireless Broadband System- ENCOM E-Lite 5.8 GHz**
 - **3) Industrial Ethernet Switch- ML510D from Actelis Networks**
 3. Provide an Inventory of existing software used on the controllers?
 - **Answer: The Respondent shall take inventory of the software used on existing controllers as part of the overall scope of the project.**
 4. Can the city Clarify the ATMS scope of work (briefly looking the conflict appears at the start of section 2.2)?
 - **Answer: Replace the first two sentences of the first paragraph of Section 2.2 with “The cost for professional services for the design phase of Project is currently budgeted at \$236,981. Such budget does not include furnishing Advanced Transportation Management System (“ATMS”) Software or Construction Engineering services, both of which are part of this RFP but are funded by the construction phase of the project.”**
 5. Is the City requiring both the Sample Cost Proposal 1 and the Sample Cost Proposal 2 to be filled out, or is there only one form required? Can the City please confirm which form(s) are required?
 - **Answer: A cost proposal based on Sample Cost Proposal 2 (Specific Rates of Compensation) is required for all Proposers for at least the Construction Engineering phase of the project, as the required level of effort cannot be well enough estimated for a lump sum proposal prior to completion of the design phase. A cost proposal utilizing Specific Rates of Compensation on a Not to Exceed basis is also acceptable for the design phase of the project. If Proposer elects to provide a lump sum cost proposal (instead of a NTE cost proposal) for the design phase of the project, then it shall be based on Sample Cost Proposal 1.**
 6. Is this requirement also applicable to any included tables, charts, exhibits, callouts, and graphics, or can a smaller font be used for these elements so that they may present more succinctly?
 - **Answer: Tables, charts, exhibits, callouts, and graphics are exempt from the 11 pt font. The aforementioned must be reasonably legible.**

7. In Section 4.3.6 of the RFP, it is stated that Part 5 – Project Approach must include “a detailed description (maximum five pages) of the Proposer’s approach for managing the team & performing its services.” Is this 5-page limit meant to include *all* items listed in that section, including the quality plan, detailed schedule, and detailed scope of work?
- **Answer: All page limits are removed. The city encourages concise Proposals that are responsive to the RFP minimum content requirements. Proposals should not include standard marketing or other general materials. Only include relevant information in the Proposal.**
8. There is a conflict between the March completion date and the City’s turnaround time on reviewing submittals, which date governs?
- **Answer: The City’s time to return submittals will govern, therefore the March Completion date may be extended to accommodate appropriate time for City review.**
