January 10, 2024

CALL TO ORDER:

The City Council of the City of Atwater met in Special Session this date at 4:35 PM in the City Council Chambers located at the Atwater Civic Center, 750 Bellevue Road, Atwater, California; Mayor Nelson presiding.

Assistant City Clerk closed the nomination period.


