8. **2024 Housing Element Annual Progress Report**

MOTION: Council Member Raymond moved to receive and file the report; seconded by Council Member Cale.

VOTE: Motion passed unanimously.

9. **Fruitland Avenue Reconstruction Project Phase 3 – Budget Amendment and Change Order**

MOTION: Council Member Rochester moved to adopt Resolution No. 3534-25 and approve Change Order No. 9 to George Reed Inc.; seconded by Council Member Raymond.

VOTE: Motion passed unanimously.

10. **Presentation – JLB Engineering on Fruitland-Chardonnay Intersection with possible direction**

MOTION: Council Member Rochester moved to halt all paving at the intersection of Fruitland Avenue and Chardonnay Drive; Identify all available options for cost

recovery, including holding VVH financially responsible for any corrective work that must be performed; and with written approval from the City's Traffic Engineer, proceed to work with George Reed, Inc. to reconstruct the bulb-outs to bring them into compliance with applicable design standards; seconded by Mayor Nelson.

VOTE: Motion failed.

MOTION: Council Member Raymond moved to approve the paving of all areas on Fruitland Avenue except for the specific area around the intersection of Chardonnay and Fruitland, to allow for the completion of re-engineering work related to the bulb-outs. Additionally, staff is directed to proceed with surveying work to determine the precise formation points for the infrastructure in the affected intersection area; seconded by Council Member Ambriz.

VOTE: Motion passed.

Public comments were received regarding various local concerns, including code enforcement, infrastructure improvements, and future development plans.

One case of anticipated litigation was discussed.


